Highlights:

- The pre-bid conference was called to order by Ms. Mercedita G. Abutal at 9:00 AM;
- It was conducted in mixed platform, physically and by skype due to GCQ;
- She acknowledged the presence of everyone in the room as well as BAC members, TWG, DOST IV- A representatives and prospective bidders who joined thru skype;
- Motion was raised to go directly to the Technical Specifications since all bidders were already familiar with the eligibility requirements as this project is already a rebidding and

to have ample time to clarify with regards to the scope of work;

- Engr. Luces with the TWG discussed the scope of work of the above project;
- Specific height of the container van is at least 2.4m, excluding the height of the wheel;
- The TWG agreed that the mobile dryer with capacity of 4,6,8 and 12 tons and the mobile sugarcane harvester will be accepted as similar contract, provided that the bidder has experience in the fabrication of large chassis;
- It was emphasized that the project requires that the interested bidder should have experience in fabrication of large chassis;
- Provision of necessary improvement of the system to achieve its performance requirements may be done during the implementation; the winning bidder and project team will discuss first the drawing before fabrication of the prototype;
- Although majority of the bidders agreed on motorized system, the TWG mentioned that they do not limit the choice of the bidders as to motorized or hydraulic system. It depends on the prerogative of the bidders;
- TWG mentioned that functionality of the unit is a factor in the evaluation of the proposals to be submitted, whichever mechanism the bidders have opted;
- Estimated total load of the unit is 2tons, single axle, double tire;
- Initial drawings and TOR serves as common reference to all the bidders;
- Sample videos of collapsible food hub can be searched via youtube; sample link will also be sent to prospective bidders;
- List of major materials will be provided by the TWG;
- There being no other matters to be discussed, the pre bid conference was adjourned at 11:30 A.M.
