

**BAC RESOLUTION DECLARING NOTICE OF AWARD AND
RECOMMENDING FOR APPROVAL**

**Project: PROCUREMENT OF ONE LOT AUTOMATIC GAUGE BLOCK
COMPARATOR WITH DUAL GAUGE HEADS INCLUDING
ENCLOSURE AND COOLING SYSTEM-REBIDDING**

Approved Budget for the Contract (ABC): Php10,000,000.00

Whereas, the Metals Industry Research and Development Center (MIRDC) posted the Invitation to Bid for the above project on Dec. 29, 2019 in the Philippine Government Electronic Procurement System (PhilGEPs), Metals Industry Research and Development Center (MIRDC) websites and conspicuous places at the premises of the DOST Bicutan, Taguig City continuously for 23 days;

Whereas, a pre-bid conference was conducted on Jan. 9, 2020; 9AM and attended only by MESCO INC.;

Whereas, in response to the said invitation, only MESCO INC signified their intention to join the bidding and subsequently purchased the bidding documents.;

Whereas, lone bidder MESCO INC submitted their bid during the Bid opening on Jan. 22, 2020 9:00 a.m. at the Mercury Conference Room, 3rd Floor, Gold Building, MIRDC Compound, Gen. Santos Ave., Bicutan, Taguig City;

Whereas, MESCO INC. passed the eligibility requirements and was scheduled for post-qualification;

Whereas, after verifying, validating and ascertaining its documents, MESCO INC. passed all the criteria for post-qualification;

Whereas, Sec 36 (a) of the 2016 Revised Implementing Rules and Regulations of RA 9184 states:

"A Single Calculated and Responsive Bid (SCRB) shall be considered for award if...

(a) "If after advisement, only one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements;"

RESOLVED, as it is hereby resolved, pursuant to Section 53 of R.A. 9184, to declare MESCO INC. as the Single Calculated and Responsive Bidder and to recommend the award of contract to said bidder at its submitted/ calculated bid price.
