Whereas, the Metals Industry Research and Development Center (MIRDC) posted the Invitation to Bid for the above project on November 23, 2020 in the Philippine Government Electronic Procurement System (PhilGEPS), Metals Industry Research and Development Center (MIRDC) websites and conspicuous places at the premises of the DOST Bicutan, Taguig City;

Whereas, a pre-bid conference was conducted on 29 October 2020 and attended by the following bidders: ROMSAM Construction Inc., MPZ Carreon Builders and Square Cube Construction;

Whereas, in response to the invitation, the following bidders signified their intention to join the bidding and subsequently purchased the bidding documents: MPZ Carreon Builders and Square Cube Construction;

Whereas, the opening of bids was held on November 11, 2020 at the MIRDC Mercury Conference Room, 3rd Floor, Gold Building, MIRDC Compound, Gen. Santos Ave., Bicutan, Taguig City. It was conducted in a mixed platform, physically and by video conferencing (zoom);

Whereas, the following bidders were able to comply with the technical/eligibility requirements, hence, their financial proposals were opened and read to wit:

Whereas, Square Cube Construction being the lowest calculated bid was scheduled for post-qualification;

Whereas, after verifying, validating and ascertaining its documents, Square Cube Construction passed all the criteria for post-qualification;

RESOLVED, as it is hereby resolved, pursuant to Section 34.4 of R.A. 9184, to declare **Square Cube Construction** as the **Lowest Calculated and Responsive Bidder** and to recommend to HOPE that the contract for the **“SUPPLY OF LABOR AND MATERIALS FOR THE RENOVATION OF MIRDC MWSII BUILDING ZONE 1D AND 2D”** be awarded to Square Cube Construction at its submitted/calculated bid price;
