**Project: Supply of Labor and Materials for the Development of Deployable and Collapsible Food Hub Including Fabrication of Chassis Components, Food Hub Framing, Electrical and Automation Works - Negotiated**

**Approved Budget for the Contract (ABC): Php2,700,000.00**

**Opening of Bids: August 25, 2020;9AM**

WHEREAS, MIRDC declared a First and Second Failure of Biddings for the above-mentioned project under BAC Resolutions Nos. 2020-027 and 2020-028, respectively;

WHEREAS, due to two-failed biddings, the Bids and Awards Committee resorted to Negotiated Procurement under Two-Failed Biddings (Sec 53.1 of the updated 2016 Revised IRR of RA 9184);

WHEREAS, the BAC invited suppliers/fabricators and posted the Invitation to Bid in the Philippine Government Electronic Procurement System (PhilGEPS), MIRDC Website, and conspicuous places at the premises of DOST on May 29, 2020 and June 29, 2020;

WHEREAS, in response to the said posting, only FILGENIUS ENTERPRISE submitted its bid electronically thru a password-protected file during the bid opening on August 25, 2020;

WHEREAS, FILGENIUS ENTERPRISE passed the technical, financial requirements and the legal requirements.

WHEREAS, after careful validation, verification and detailed evaluation of the bid of FILGENIUS ENTERPRISE by the Technical Working Group, the team found FILGENIUS ENTERPRISE to have passed the criteria for post-qualification and is responsive to the requirements and conditions for eligibility and the bidding of the contract as specified in the bidding documents;

WHEREAS, the BAC deliberated on FILGENIUS ENTERPRISE's bid proposal of Two Million Seven Hundred Thousand Pesos (Php2,700,000.00) and considered it as the Best and Final Offer;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby

RESOLVE as it is hereby RESOLVED, to declare FILGENIUS ENTERPRISE's offer as the Best and Final Offer and to recommend the award of contract to it for the Negotiated Procurement on "Supply of Labor and Materials for the Development of Deployable and Collapsible Food Hub Including Fabrication of Chassis Components, Food Hub Framing, Electrical and Automation Works" for approval by the Executive Director.
