Whereas, the Metals Industry Research and Development Center (MIRDC) posted the Invitation to Bid for the above project on Nov. 24, 2020 in the Philippine Government Electronic Procurement System (PhilGEPS), Metals Industry Research and Development Center (MIRDC) website and conspicuous places at the premises of the DOST Bicutan, Taguig City continuously for 20 days;

Whereas, a pre-bid conference was conducted on Dec. 2, 2020 and attended by the following bidders: GECAR MACHINE SOLUTIONS INC., UNOTRONIX INC, SCUDERIA ENTERPRISES, HUMIL INTERNATIONAL and VELCA EQUIPMENT AND ENGINEERED PRODUCTS, INC.;

Whereas, in response to the invitation, the following bidders signified their intentions to join the bidding and subsequently purchased the bidding documents: GECAR MACHINE SOLUTIONS INC., and UNOTRONIX INC;

Whereas, the opening of bids was held on Dec. 14, 2020 at the MIRDC Mercury Conference Room, 3rd Floor, Gold Building, MIRDC Compound, Gen. Santos Ave., Bicutan, Taguig City. It was conducted in a mixed platform i.e physical and video conferencing (zoom);

Whereas, Gecar Machine Tools Inc. was disqualified for its failure to comply with the technical requirements, ie., two (2) parameters were omitted in the statement of compliance with the Technical Specifications.

Whereas, UNOTRONIX INC. passed the requirements on the eligibility and technical proposals having complied and submitted all the required documents. Hence, the BAC proceeded to open their financial proposals.

Whereas, the bid offer of UNOTRONIX INC. was read as Php 4,698,000.00.

Whereas, UNOTRONIX INC. being the single calculated bid was scheduled for postqualification and was found to be responsive;

Whereas, Sec 36 (b) of the 2016 Revised Implementing Rules and Regulations of RA 9184 states:

"A Single Calculated and Responsive Bid (SCRB) shall be considered for award if...

b) If after advertisement, more than one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, but only one bidder meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements;

Now, therefore, The BAC hereby RESOLVED, as it is hereby RESOLVED, pursuant to Section 36 (b) of R.A. 9184, to declare UNOTRONIX INC. as the Single Calculated and Responsive Bidder (LCRB) and to recommend to HOPE that the contract for the "PROCUREMENT OF ONE (1) LOT INDUCTION MELTING FURNACE" be awarded to UNOTRONIX INC., at its submitted/ calculated bid price.
