Whereas, the Metals Industry Research and Development Center (MIRDC) posted the Invitation to Bid for the above project on Oct. 14, 2020 in the Philippine Government Electronic Procurement System (PhilGEPS), Metals Industry Research and Development Center (MIRDC) website and conspicuous places at the premises of the DOST Bicutan, Taguig City continuously for 20 days;

Whereas, a pre-bid conference was conducted on Oct. 22, 2020 and attended by the following bidders: Edman Machtools Inc., Gecar Machine Solutions Inc., Hytec Power Inc., Hinoki Global Inc., Humil International Inc., Mesco, Inc., and Techline Inc;

Whereas, in response to the invitation, the following bidders signified their intention to join the bidding and subsequently purchased the bidding documents: Gecar Machine Solutions, Inc., Hytec Power Inc., Hinoki Global Inc., Humil International Inc., and Scuderia Enterprise;

Whereas, the opening of bids was held on Nov. 5, 2020 at the MIRDC Mercury Conference Room, 3rd Floor, Gold Building, MIRDC Compound, Gen. Santos Ave., Bicutan, Taguig City. It was conducted in a mixed platform, physically and by video conferencing (zoom);

Whereas, HINOKI INTERNATIONAL was disqualified because the single largest completed contract it declared was not similar to the contract to be bid. Also, it did not state its compliance against the individual parameter of the Technical Specifications. Thus, the BAC did not proceed to open their financial proposal;

Whereas, the following bidders were able to comply with the technical / eligibility requirements, hence, their financial proposals were opened and read to wit:
