

Contract Agreement Form

THIS AGREEMENT made this 4th day of September 2020 between **METALS INDUSTRY RESEARCH AND DEVELOPMENT CENTER**, with office address at General Santos Avenue, Bicutan, Taguig City, represented herein by its Executive Director, **ROBERT O. DIZON**, hereinafter called "the Procuring Entity" and **FILGENIUS ENTERPRISE** with office address at 1269 E. Delos Santos Avenue, Balintawak, Apolonio, Quezon City, represented herein by its Logistics Supervisor, **ACE ANTONIO CRISTOBAL** hereinafter called "the Supplier".

WHEREAS the Procuring Entity invited Bids for certain goods and ancillary services, viz., "Supply of Labor and Materials for the Development of Deployable and Collapsible Food Hub Including Fabrication of Chassis Components, Food Hub Framing, Electrical and Automation Works-Negotiated" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Million Seven Hundred Thousand Pesos Only (Php2,700,000.00)** hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and and
 - (g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


