You are advised that the Purchase Order for the **"SUPPLY AND INSTALLATION OF FIRE FIGHTING SYSTEM FOR THE CENTER (PHASE II) - REBIDDING"** of the Metals Industry Research and Development Center has been awarded to your firm in the amount of Fourteen Million Eight Hundred Sixty Nine Thousand Four Hundred Seventy Pesos Only (**Php14,869,470.00**), subject to the approval of the concerned authorities.

Contract Agreement Form



THIS AGREEMENT made the 29th day of January 2019 between **METALS INDUSTRY RESEARCH AND DEVELOPMENT CENTER**, with office address at General Santos Avenue, Bicutan, Taguig City, represented herein by its Executive Director, **ROBERT O. DIZON**, hereinafter called "the Entity" and **LJM FIRE PROTECTION SERVICES AND TRADING** with office address at Unit 4 Karldale Square Building National Highway, Brgy San Pedro, Puerto Princesa City, Palawan represented herein by its Proprietor **CARMELITO C. DATAN**, hereinafter called "the Supplier".

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., *"SUPPLY AND INSTALLATION OF FIRE FIGHTING SYSTEM FOR THE CENTER (PHASE II) - REBIDDING"* and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Fourteen Million Eight Hundred Sixty Nine Thousand Four Hundred Seventy Pesos Only (Php14,869,470.00)** hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:



1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

- (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and and
 - (g) the Entity's Notice of Award.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.



5. The Entity adopts countertrade as a supplemental trade tool in connection with transactions involving the importation or procurement of foreign capital equipment, machinery, products, goods and services entailing the payment of at least US \$1,000,000 or its equivalent in other foreign currency. As such, in the event that the Supplier's sum of the contracts for goods supplied by importation reaches US \$1,000,000, the Supplier shall be required to perform Countertrade equivalent to at least fifty percent (50%) of the foreign exchange value of the imported equipment to be supplied under this Supply Agreement. The terms and conditions relative hereto shall be agreed upon between the Supplier (or its nominated Trading Company) and Philippine International Trading Corporation (PITC), the Philippine Government's countertrade agency, under a separate Contract/ Agreement which must be signed no later than ninety (90) days from the date of the signing of this Supply Contract.


