Whereas, the **Metals Industry Research and Development Center (MIRDC)** posted on August 2, 2017 in the Philippine Government Electronic Procurement System (Philgeps), Metals Industry Research and Development Center (MIRDC) websites and conspicuous places at the premises of the DOST Bicutan, Taguig;

b.) The Short listed consultant shall be invited to participate in the bidding for this project.




