

BAC RESOLUTION DECLARING SHORT LISTED FOR CONSULTANCY

Project: "Consultancy Service for the Conduct of Pre-Feasibility Study on the Setting Up of a PH Ironmaking Facility."

Approved Budget Contract (ABC): Php2,000,000.00

Pre-procurement Conference: July 26, 2017

Submission/Opening of Eligibility Documents: August 15, 2017

Whereas, the **Metals Industry Research and Development Center (MIRDC)** posted on August 7, 2017 in the Philippine Government Electronic Procurement System (Philgeps), Metals Industry Research and Development Center (MIRDC) websites and conspicuous places at the premises of the DOST Bicutan, Taguig;

Whereas, in response to the said advertisement, the three bidders, Dastur International Inc., Infoshare Management Systems and Minercon International Inc., signified their interests to join the Opening of Eligibility of Documents;

Whereas, a Submission/Opening of Eligibility of Documents was conducted on August 15, 2017. Dastur International Inc. and Infoshare Management Systems were found eligible. Minercon International Inc. was disqualified because of non-submission of PhilGEPS Platinum Certificate;

Whereas, upon careful examination, validation and verification of all the eligibility, the Technical Working Group concluded. Only Dastur International Inc. met the minimum total score using the QBE procedure while Infoshare Management Systems did not passed in short listing process because it did not met the required minimum score of 70 such that;
