
Form of Contract Agreement

THIS AGREEMENT, made this 11th day of May, 2018 between *Metals Industry Research and Development Center* (hereinafter called the "Entity") and *Well-Built Specialty Contractors, Inc.* (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute "*Supply of Labor, Materials, Tools, Equipment and Technical Supervision for the Retrofitting of MIRDC Gold Building Basement Phase III*" (hereinafter called "the Works") and the Entity has accepted the Bid for *Four Million Five Hundred Sixty Eight Thousand Three Hundred Twenty Eight Pesos and 13/100 (PhP4,568,328.13)* by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Drawings/Plans;
 - (c) Specifications;
 - (d) Invitation to Bid;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.




3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.



Whereas, the Metals Industry Research and Development Center (MIRDC) posted the Invitation to Bid for the above project on March 20, 2018 in the Philippine Government Electronic Procurement System (PhilGEPS), Metals Industry Research and Development Center (MIRDC) websites and conspicuous places at the premises of the DOST, Bicutan, Taguig City;

Whereas, in response to the said advertisement, only Well-Built Specialty Contractors, Inc., signified its intention to join and attended the pre-bid conference last March 27, 2018;

Whereas, Well-Built Specialty Contractors, Inc., purchased the bidding documents and attended the bid opening on April 10, 2018 at 09:00 a.m. at the Mercury Conference Room, 3rd Floor, Gold Building, MIRDC Compound, Gen. Santos Ave., Bicutan, Taguig City;

Whereas, only Well-Built Specialty Contractors, Inc., submitted its eligibility documents during bid opening and passed the preliminary evaluation;

Whereas, Sec. 36 of the 2016 Revised IRR of R.A. 9184 states:

A Single Calculated and Responsive Bid shall be considered for award if it falls under any of the following circumstances:

- 1. If after advertisement, only one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements;*

Whereas, the BAC/TWG conducted a Post-qualification evaluation to Well-Built Specialty Contractors, Inc. on April 16, 2018 and the bidder passed the post-qualification evaluation and been determined as a Single Calculated and Responsive Bidder;




