



**INVITATION TO BID FOR
ONE (1) LOT SUPPLY, DELIVERY, INSTALLATION

The *METALS INDUSTRY RESEARCH AND DEVELOPMENT CENTER*, through the *MIRDC FY 2021 GLA Project "Advancement of Information and Communications Technology (ICT) and Implementation of Information Security Management System (ISMS) in MIRDC (AIM) - ICT AIM"*, *Machinery and Equipment Outlay* - intends to apply the sum of **Two million three hundred ninety-six thousand pesos (Php 2,396,000.00)** being the ABC to payments under the contract for Procurement of **ONE (1) LOT SUPPLY, DELIVERY, INSTALLATION OF PRECISION AIR CONDITIONING UNIT (PACU) WITH ENVIRONMENTAL MONITORING SYSTEM AND FIRE SUPPRESSION SYSTEM FOR MIRDC DATA CENTER**; PR# 22010004.
2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The *METALS INDUSTRY RESEARCH AND DEVELOPMENT CENTER* now invites bids for the above Procurement Project. Delivery of the Goods is one hundred eighty **(180)** calendar days from the date of acceptance of the Notice to Proceed (NTP). Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

7. The **METALS INDUSTRY RESEARCH AND DEVELOPMENT CENTER** will hold a Pre-Bid Conference on *December 7, 2021, 9am* physically and through video conferencing via ZOOM application, which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below, or (ii) online/electronic submission thru a password-protected bidding documents on or before *December 21, 2021; 1:00pm.* Late bids shall not be accepted.
9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
10. Bid opening shall be *December 21, 2021; 1:00pm.* at the given address below or via *zoom application.* Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
